## **Update November 24**: COVID Cases and Deaths Among People with Disabilities and Older Adults in Wisconsin

(Madison) – The Survival Coalition of more than 30 disability organizations supports the work of the Wisconsin Department of Health Services and the Governor Evers' administration to share regularly updated data regarding the impacts of COVID-19 in Wisconsin's Medicaid Adult Home and Community-Based Services system. People with disabilities and older adults, particularly those who live in congregate or group settings have proven to be particularly vulnerable to the virus.

## Total cases by adult Medicaid HCBS waiver program type

Program enrollment data is point-in-time from most recent published month for each program type (currently September 1 for managed LTC and November 1 for IRIS).

Participants in Wisconsin's waiver programs, typically referred to as Family Care and IRIS, comprise 16.6% of the state's total deaths.

According to DHS data, 26.7% of cases in the waiver system result in hospitalization and 9.0% result in death, compared to 4.5% and .9% in the general state population, respectively.
